## Sample Bequest Language

The provision in your will or revocable living trust providing for a gift to St. Andrew's Presbyterian Church of Newport Beach should reflect your own unique circumstances and charitable objectives. We hope these samples will be helpful to you and your attorney.

If at any time in the judgment of the Church it is impossible or impracticable to carry out the purpose I have designated, the Church shall determine an alternative purpose as near as possible to the designated purpose."

Gift from Investment or Retirement Accounts: You may choose to designate St. Andrew's Presbyterian Church of Newport Beach as beneficiary of all or part of your investment account or retirement account.
